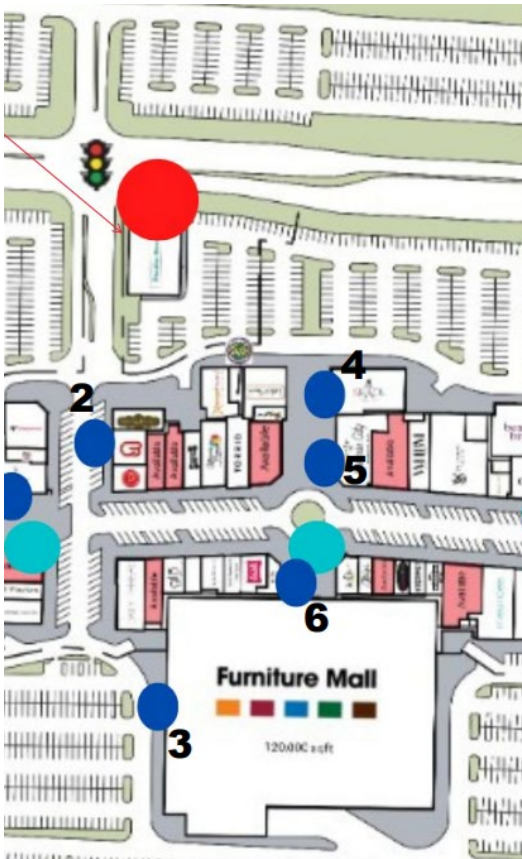

We would like to reserve a banner stand during the holiday season to promote our gift cards and will need your authorization and map of sign location for the city permit. We are awaiting the proof for the 3'x8' banner, but it will be very similar to the proof for our A-Frame – see attached.
