3. 2017 NEC Article 210.63 Heating, Air-Conditioning, and Refrigeration Equipment Outlet. A 125-volt, single-phase, 15- or 20-ampere-rated receptacle outlet shall be installed at an accessible location for the servicing of heating, air-conditioning, and refrigeration equipment. The receptacle shall be located on the same level and within 25 feet of the heating, air-conditioning, and refrigeration equipment. The receptacle outlet shall not be connected to the load side of the equipment disconnecting means. See E 200

Action required: Provide receptacle(s) on roof within 25' of new equipment or provide verification of existing. **2/10/2025** - Not addressed. Receptacle provided for one RTU but exhaust fans and condensing unit are not covered.
