### **Licensed Contractors**

1. MEP subcontractors are required to be listed on permit. Provide company names of license MEP contractors.

### **Building Plan Review**

 The building permit for this project cannot be issued until the Development Services Department has received, approved, and processed the Final Development Plan.

This project has received Final Development Plan approval with stamped drawing set dated 10/16/2024.

- 2. A one-time impact fee in the form of a license/excise tax in the amount of \$31,605.25 must be collected before occupancy can be granted. *Understand and will comply.*
- 3. Provide Cleanout near where sanitary leaves the building. Refer sheet PE200S. The cleanout has been added.
- **4.** Update RTU schedule to show smoke detectors at RTU-7. Refer sheet MP300S. The RTU schedule has been updated.
- 5. Provide panic hardware at door 03 out of Electrical Room. Refer sheet A6.0. Panic hardware has been added to door 03.

## 6. Provide grounding electrode to water service entry.

Refer sheet E3.0S. Added grounding electrode conductor to cold water service pipe (note #10) on Electrical Riser Diagram.

## 1. Provide deferred submittal for alarm system.
