1. A code analysis shall be provided which includes but is not limited to occupancy type, occupant load, construction type, actual area, height and floors, allowable area, height and floors, and the codes to which the project is designed.

Action required: Amend Building Code Review - this building is a fully sprinklered 2B.

2. 2018 IBC 1109.12.3 Point of sale and service counters. Where counters are provided for sales or distribution of goods or services, at least one of each type provided shall be accessible. Where such counters are dispersed throughout the building or facility, accessible counters shall also be dispersed.

Action required: Service counters must be fully accessible (min. 36" of surface at a maximum 36" high). To be field verified.

4. 315.3.1 Ceiling clearance. Storage shall be maintained 2 feet (610 mm) or more below the ceiling in nonsprinklered areas of buildings or not less than 18 inches (457 mm) below sprinkler head deflectors in sprinklered areas of buildings.

Action Required: Need plans showing the hight of the storage on racks to be no closer than 18" to the sprinklers.

5. 2018 IFC 1008.1 Illumination required. The means of egress, shall be illuminated at all times the building space served by the means of egress is occupied.

Action Required: Plans do not show emergency and exit lighting.

The review conducted by the City of Lee's Summit Development Services Department shall not be construed as a structural review of the project.
