1 2018 IBC 502.1 Address identification. New and existing buildings shall be provided with approved address identification. The address identification shall be legible and placed in a position that is visible from the street or road fronting the property. Address identification characters shall contrast with their background. Address numbers shall be Arabic numbers or alphabetical letters. Numbers shall not be spelled out. Each character shall be a minimum of 4 inches high with a minimum stroke width of ½ inch. Where required by the fire code official, address identification shall be provided in additional approved locations to facilitate emergency response. Where access is by means of a private road and the building address cannot be viewed from the public way, a monument, pole or other approved sign or means shall be used to identify the structure. Address identification shall be maintained.

Where water pressure within a building exceeds 80 psi static, an approved water-pressure reducing valve conforming to ASSE 1003 or CSA B356 with strainer shall be installed to reduce the pressure in the building water distribution piping to not greater than 80 psi static.

Action required: Provide pressure reducing value at water entry. (Our Water Department requires PRV installation in all locations regardless of pressure) To be field verified

6 Informational notes for townhome review. Items not found in plans that will be verified during inspections.

- Doors between garages and living units must be 20 minute fire rated and be self closing.

- Wall insulation to be minimum R-13.

- Ceiling insulation to be minimum R-30. (or R-19 if part of roof assembly)

7 Foundation and underlsab plumbing only released at this time. Substantial completion on the santiary and water before private connections can be made. Full access and live hydrants required prior to release of vertical construction.
