1 Misc 7-15-24 DP. Coltons crew set the first backflow pit and installed the 12"x6"

Tee. Today they are pouring the kicker for the Tee and also collars outside

the backflow pit. cross with 4 valves.

8-15-24 DP. All of private water line 1 has been installed from the backflow vault along Lee's Summit Road at STA 10+00 to where it TEE's off. Private line 1 that runs south to the backflow vault at STA 31+00 is not installed down to line 5 at north of STA 27+00. These lines can not be completed until the gas main and sanitary force main have been relocated. All other private water lines, Line 1,2,3 and 4 have been installed with kickers poured, tracer wire installed and is currently getting tested.

8-16-24 DP. I met AJ with ESS on site today and we chlorinated all of the private water that has been installed. It will sit over the weekend and flush on monday with samples following.

8-19-24 DP. AJ was onsite this morning flushing all private water.

8-28-24 DP. After flushing chlorine Reese called and couldn't get private fire hydrants to shut down. He put his hand up and felt gravel in the water. I was told that a contractor installing utility conduit hit the main in a spot and repaired the main. Reese is worried that when we were flushing or chlorinating the first time it pushed rock into the main from the break. He installed a 8" 45 and pup piece at the end of line. He is bringing out a pig today and is going to clean the line and then strip the fire hydrants and replace the rubbers.

9-09-24 DP. Colton's crew was onsite and pigged the private water line. They sent it through all of the pipe in two separate points.

9-10-24 DP. There was a guy from Muller onsite today going through and cleaning all of the private fire hydrants and replacing gaskets that got damaged.

5-6-25 DP. Sapp is onsite getting ready to install water line C. They have to lower a portion that CIP just installed. I worked with Brent to find the valve to eliminate the water line where line C is going with out any luck. ESS agreed that if we shut down the two valves with no services connected so they could do their work, that they would dig up the TEE and plug the valve this week. Locates were called in today for that work to happen later this week.
