- 3. It appears as though these drawings were in a digital format, then printed, then scanned in which makes it difficult to read some of the specs. Please upload the original digital version.
- 4. Once the request items are received, we may want to look at a Sign Application which goes to Planning Commission for the complete package because the quantity of signs exceeds what would typically be allowed within the zoning district.
