Dear Mr. Wilhelm:

This letter is in response to your recent request submitted on behalf of Whispering Woods Land, LLC, for a Department of the Army permit. It was received on November 6, 2023. The proposed work concerns a residential development within an approximate 2-acre area of a larger project site which will involve the placement of fill material within Mouse Creek and an adjacent wetland. The project is located in Section 24, Township 47 north, Range 32 west, Jackson County, Missouri.

This letter contains an approved jurisdictional determination for your project site. This jurisdictional determination is valid for a 5-year period from the date of this letter unless new information warrants revision of the determination before the expiration date. If you object to this determination, you may request an administrative appeal under Corps regulations at 33 CFR Part 331. Enclosed you will find a Notification of Administrative Appeal Options and Process and Request for Appeal (NAO-RFA) form. If you request to appeal this determination, you must submit a completed NAO-RFA form to the Northwestern Division Office at the following address:

In order for an NAO-RFA to be accepted by the Corps, the Corps must determine that it is complete, that it meets the criteria for appeal under 33 CFR Part 331.5, and that it has been received by the Division Office within 60 days of the date of the NAO-RFA. Should you decide to submit an NAO-RFA form, it must be received at the above address by March 4, 2024. It is not necessary to submit an NAO-RFA form to the Division Office if you do not object to the determination in this letter.

In the event that you disagree with an approved jurisdictional determination, and you have **new information** not considered in the original determination, you may request reconsideration of that determination by the Corps District prior to initiating an appeal. To request this reconsideration based upon new information, you must submit the completed NAO-RFA form and the new information to the District Office so that it is received within 60 days of the date of the NAO-RFA. The Corps of Engineers has jurisdiction over all waters of the United States. Discharges of dredged or fill material in waters of the United States, including wetlands, require prior authorization from the Corps under Section 404 of the Clean Water Act (33 USC 1344). The implementing regulation for this Act is found at 33 CFR 320-332.

We have reviewed the information furnished and have determined that your project is authorized by nationwide permit (**NWP**) **29**, **Residential Developments**, provided you ensure that the conditions listed in the enclosed copy of excerpts from the January 13, 2021, U.S. Army Corps of Engineers (Corps) (86 FR 2744 and the correction at 86 FR 27274), Reissuance and Modification of Nationwide Permits, are met. You must also comply with the Kansas City District Regional NWP Conditions posted at: <a href="http://www.nwk.usace.army.mil/Missions/RegulatoryBranch/NationWidePermits.aspx">http://www.nwk.usace.army.mil/Missions/RegulatoryBranch/NationWidePermits.aspx</a>.

In addition to the general and regional conditions of this NWP, a special condition has been added in order to replace the lost aquatic resources that result from the authorized project.

The applicant must purchase 0.18 wetland acres or 1.35 wetland credits; and 4,387 stream credits from an approved mitigation provider within this service area. At this time, credits may be obtained only from the ESS Green, Blackwater-Lamine Umbrella Bank and the Swallowtail LLC-Blackwater-Lamine Umbrella Bank. Credit availability is subject to market change; therefore, you must contact this office to verify credit availability prior to completing the transaction. The purchase of the compensatory mitigation must be completed prior to the commencement of work within our regulatory jurisdiction.

You must notify the project proponent that they must submit a receipt of payment from the mitigation sponsor that includes the amount of credits purchased and the date of credit purchase. Receipts submitted by authorized agents will not be accepted. Please be aware that the endangered Indiana bat (Myotis sodalis), gray bat (Myotis grisescens) and northern long-eared bat (Myotis septentrionalis) may be present within your project area. To "not adversely affect" these listed species, you must not cut trees during the bats' active season, April 1 — October 31, during any year this permit verification remains valid. If implementation of the seasonal tree cutting restriction is not possible, please contact the Corps of Engineers, Regulatory Branch, for further consultation with the United States Fish and Wildlife Service.

The Missouri Department of Natural Resources has certified that this NWP will not violate existing state water quality standards provided you comply with the conditions included in the attached Missouri Section 401 Water Quality Certification (WQC) document. All conditions included in the WQC are conditions of the NWP authorization. Please review all conditions associated with this NWP. Per 40 CFR Part 121.11(c) the Corps is responsible for enforcing WQC conditions that are incorporated into this permit verification. If you

have any questions concerning state WQC standards or compliance issues with the associated certification conditions, please contact the project manager at the phone number and/or email provided below.

General condition 30 requires you to sign and submit the enclosed "Compliance Certification" within 30 days of completing the authorized activity or the completion of the implementation of any required compensatory mitigation.

This NWP verification is valid until March 14, 2026. Should your project plans change or if your activity is not complete within this specified verification term, you must contact this office for another permit determination. Although the Corps has verified your project would meet the terms and conditions of a nationwide permit, other Federal, state and/or local permits may be required. You should verify this yourself.

The delineation included herein has been conducted to identify the location and extent of the aquatic resources for purposes of the Clean Water Act for the particular site identified in this request. This delineation may not be valid for the Wetland Conservation Provisions of the Food Security Act of 1985, as amended. If you or your tenant are USDA program participants, or anticipate participation in USDA programs, you should discuss the applicability of an NRCS Certified Wetland Determination with the local USDA service center, prior to starting work.
