Field Inlet	NW corner	Remove built up silt around box and reset silt fence if needed
Grate Inlets	In soon to be alley	Need to protect grate inlets- install silt fence inside grat- see picture below
Silt fence	Along backfilled curb	Install silt fence along backfilled curb throughout site
Inlet/Street	Various	Clean out various inlets, curbs, and streets throughout entire site
Silt fence	Along curb	New Gordon silt fence installed needs to either be closer to the curb or built up dirt from install needs to be lower than the curb- PER CITY—SEE PICTURE
Silt fence	Along curb	Repair various areas where fence has been ran over along curb
Trash	Whole Site	Remove trash dumped throughout site- Lots of tires
Silt fence	Detention Pond	Repair silt fence along detention pond- North end
Silt fence	Perimeter	Entire perimeter needs silt fence repaired/replaced in various areas
