


Lee's Summit, Jackson County, Missouri



All of Lot 231, Cornerstone at Bailey Farms, First Plat, as recorded in the Office of the Recorder, Jackson County, Missouri, as Document No. 2025E0026694. Containing 0.27 acres more or less.

EASEMENTS:

GRANTOR, ON BEHALF OF HIMSELF, HIS HEIRS, HIS ASSIGNS AND SUCCESSORS IN INTEREST, HEREBY WAIVES, TO THE FULLEST EXTENT ALLOWED BY LAW, INCLUDING, WITHOUT LIMITATIONS, SECTION 527.188, RSMo (2006), ANY RIGHT TO REQUEST RESTORATION OF RIGHTS PREVIOUSLY TRANSFERRED AND VACATION OF THE EASEMENTS HEREIN GRANTED.

BUILDING LINES:

OIL - GAS WELLS:
