Comments / Discussion from neighbors

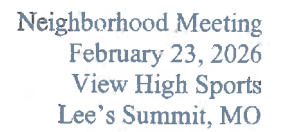
- Concerns over traffic related to the overall project utilizing the subdivision for access.
 - Discussed how the traffic is anticipated to primarily utilize Chipman and View High and the construction of the new north / south road to Chipman from Ashurst will provide access to the signal. Limited traffic is expected to utilize the subdivision streets.
- Discussion over what this application is for and the limits of what was previously approved
 - Explained how the previous Preliminary Development Plan approved the overall site and this meeting was for the Special Use Permit and Preliminary Development Plan as it relates to the Dome only
- Discussion on when construction will begin on the project
 - Construction is expected to begin Summer of 2026
- Will the parking lot and field lights on the soccer field be on all the time
 - Parking lot lighting will meet City code but will be on for security purposes during nighttime hours. The field lights will be limited to the allowable hours per the UDO
- Dome height, why 59' 11"
 - The dome height is restricted by the size of the footing at the location of the footing in relation to the field. The desire is to maintain a full-size FIFA regulation field when the dome is not present which creates a location of the footing for the dome and based on that size and dome structural requirements the dome height resulted in 59'-11"
- Can you provide construction fencing during construction to protect the trees
 - Yes
- How wide is the existing tree mass going to be
 - The construction plans are not complete yet, so we don't have an exact at every location but currently the width is a minimum of 25 feet and expands to more than 75 feet in some areas
- Where will the mechanical equipment for the dome be located
 - Not set yet but we are going to move them as far away from the residence as possible and screen them to eliminate noise as much as possible
- Can you request more police patrols
 - The Development Team does not have the ability to request additional patrols in the area
- Can you lower the field grade more
 - The grade of the field has been reduced as much as possible. Any lower and the field would require retaining walls around three sides, which create issues with ingress / egress as well as a safety concern of the wall being located near the playing surface.



- Can you rearrange the site to move the soccer field to the Western side of the site or in front of church
 - The overall site was previously approved with a separate Preliminary Development Plan, however the discussion of moving the soccer field to the western side of the site has two primary concerns.
 - 1.) Moving the field away from one set of residences moves it closer to an existing residence on View High Drive, which during the original PDP approval was discussed and the location of the field was determined to be located to limit the impact to everyone where it is currently shown
 - 2.) This field is being utilized for youth sports and soccer balls will be kicked away from the field as well as people who will be present watching the games or practice. Placing the field nearer the roadway creates the potential for safety concerns with children and/or balls going into the roadway so the field location shown was selected.
- Has the City developed a Dome ordinance or penalties if the dome is not taken down
 - The City has not created any ordinance for a dome but the Special Use Permit has the criteria / limitations for the dome use. If those are not followed the City's Neighborhood Services Department would get involved and since this Special Use Permit has an expiration date the renewal if the Developer was not following the rules would likely be much more difficult.
- How loud are the additional mechanical units going to be
 - Decibel sound is a logarithmic equation and the maximum allowable noise for the units is mandated at 60 Decibel or lower, with multiple units the equation generally equates to 1 additional Decibel per unit. Even with the added units the sound will be dissipated to lower than City allowed levels due to the distance to the property line.
- How tall are the soccer field lights
 - The design is not complete but currently the poles are around 60 feet in height
- Is the dome going to create a glowing light
 - No the dome will reduce the amount of light emitted from the field because the light within the dome will be maintained within the dome. Either way the lighting will meet the City code requirement for site lighting which does not allow light to bleed onto the adjacent property.
- Will there be road signs saying no access to the residential development
 - The development can not install signs stating no access to the residential areas, since the roadways are all public, however the developer is able to install way finding signs on the project site directing cars to utilize View High, Ashurst and Chipman Road for access.
