City Council date will be set after all subdivision related public improvements have been completed and a Certificate of Final Acceptance has been issued. In lieu of completion of public improvements, an escrow secured with cash or an irrevocable letter of credit shall be deposited with the City to secure the completion of all public improvements prior to scheduling a City Council date.

If the revised submittal deadline is not met or plans are deficient, the item will be moved to a later meeting and a new deadline will be set. Future deadlines and meeting dates can be found on the "Planning Commission Meeting Dates" handout. Dates are subject to change; we will keep you informed throughout the process.

#### **Excise Tax**

On April 1, 1998, an excise tax on new development for road construction went into effect. This tax is levied based on the type of development and trips generated. If you require additional information about this development cost, as well as other permit costs and related fees, please contact the Permitting and Plan Review Division of the Codes Administration Department at 969-1200.

### **Voluntary Residential Development Surcharge**

In a combined effort with both the R-4 and the R-7 School Districts the City of Lee's Summit is working together to educate the development community on a new program, the "Lee's Summit Voluntary Residential Development Surcharge." This is a program which will help raise capital to build new schools for our community. - 1. Please add a public easement for the domestic water meter. Please coordinate with the plans to ensure the easement is able to contain the water meter and vault, but also ensure that any retaining walls or other structures do not encroach upon the easement.
- 2. Please add a 15 foot wide private drainage easement along the southwest driveway and continuing northward beyond the north property line of Lot 3 (i.e., 5 feet would be sufficient), Kessler 1st Plat). This easement should grant perpetual access for future drainage improvements to the owners of Lot 2 and Lot 3, Kessler 1st Plat. If necessary, a sketch can be provided to better describe what is intended.
- 3. Please describe how it was determined that no abandoned oil or gas wells exist on the property. Was this from the Missouri Department of Natural Resources Division of Geology and Land Survey database, or the report on file with Planning?
