- 1. FCC REGISTRATION. Tower owners shall provide documentation (i.e., a copy of the FCC Antenna Structure Registration and any other relevant documents) indicating that each telecommunications tower is in compliance with all federal requirements. A statement declaring that the existing tower is still in compliance and will remain so after any proposed alterations or additions shall be submitted when the structure is altered or antenna(s) added.
- 2. INSPECTION REPORT. A copy of an inspection report current within the last 3 years.
- 3. INSURANCE. Proof of general liability insurance for claims from injury or death and property damage in an amount approved by the City, but not less than \$2,000,000.00 per occurrence for personal injury and \$2,000,000.00 per occurrence for property damage with the City listed as an additional insured.

4. LANDSCAPING. The new equipment shelter shall be screened from view along I-470 using evergreen trees at least 8' in height at the time of planting. Provide a landscape plan to illustrate how the screening requirement will be met. The plan shall identify the number, species and height of the proposed evergreen trees.

1. All issues pertaining to life safety and property protection from the hazards of fire, explosion or dangerous conditions in new and existing buildings, structures and premises, and to the safety to fire fighters and emergency responders during emergency operations, shall be in accordance with the 2012 International Fire Code.

Provide detailed plans for Building Permit review for the enclosure, generator, fuel storage, and fire suppression system. Approval of the FDP is conditioned on approval of the enclosure and interior systems.

2. IFC 506.1 -Where access to or within a structure or an area is restricted because of secured openings or where immediate access is necessary for life-saving or fire-fighting purposes, the fire code official is authorized to require a key box to be installed in an approved location. The key box shall be of an approved type listed in accordance with UL 1037, and shall contain keys to gain necessary access as required by the fire code official.506.1.1 Locks.An approved lock shall be installed on gates or similar barriers when required by the fire code official.

Gates shall be provided with Knox padlocks.
