- Studies Studies, such as stormwater and traffic, shall be provided in Portable Document Format (PDF).
- It is requested that each plan sheet be a maximum of 2MB.

1. STREET NAMES.

- The street suffix for Willow is incorrect. Change the suffix from Circle to Drive. Additionally, make sure the addresses labeled on all of the building footprints on Willow also reflect the correction from Circle to Drive.
- Add "NW" as the quadrant label for Willow Drive.
- Label the street on Lot 1 as NW Faith Drive.
- The addresses labeled on the building footprints on NW Faith Drive incorrectly show the street suffix as Circle. Change the labels from Circle to Drive.
- Add the street suffix "Ave" to the building footprint on Lot 1 that is addressed 619-625 Shamrock.
