AN ORDINANCE VACATING THREE EASEMENTS LOCATED AT 510 NW SHAMROCK AVENUE, 512 NW HOPE LANE AND 1801 NW O'BRIEN ROAD, IN THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Application #PL2016-028 was submitted by John Knox Village, requesting vacation of three utility easements located at 510 NW Shamrock Avenue, 512 NW Hope Lane and 1801 NW O'Brien Road, in the City of Lee's Summit, Missouri; and,

WHEREAS, the City of Lee's Summit, Missouri, accepted the plat entitled "John Knox Retirement Village, 8th Plat Resurvey" by Ordinance No. 1729, passed and adopted by the Board of Aldermen of the City of Lee's Summit on January 4, 1977; and,

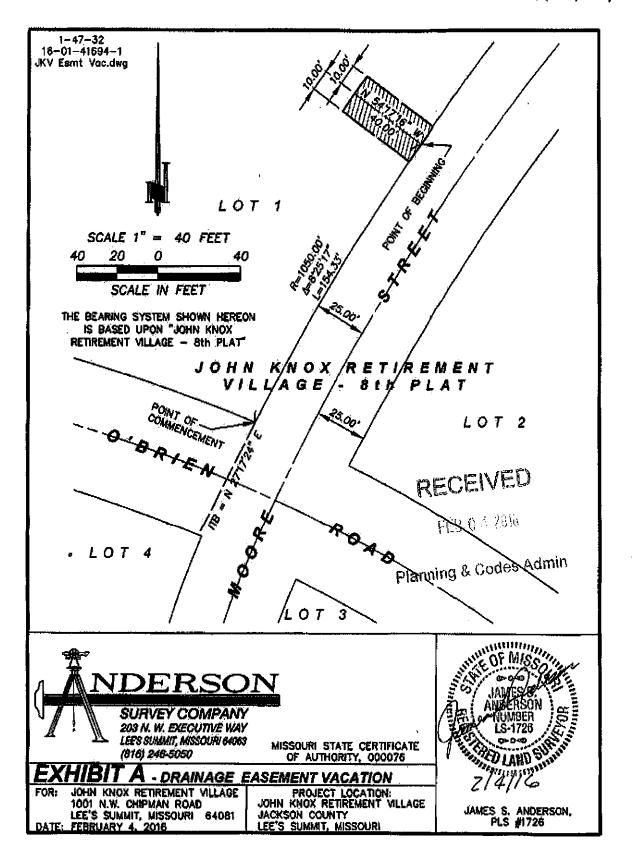

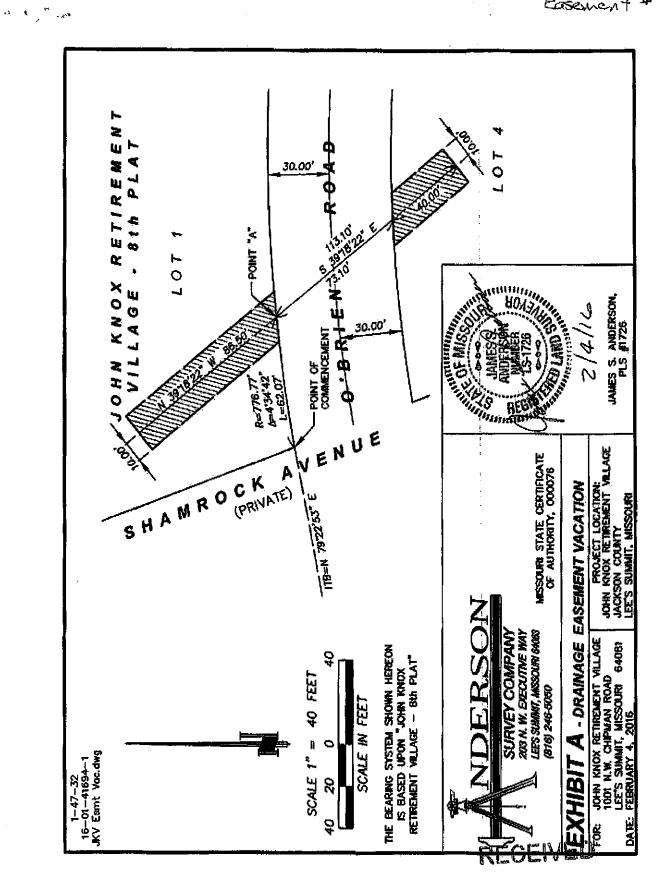

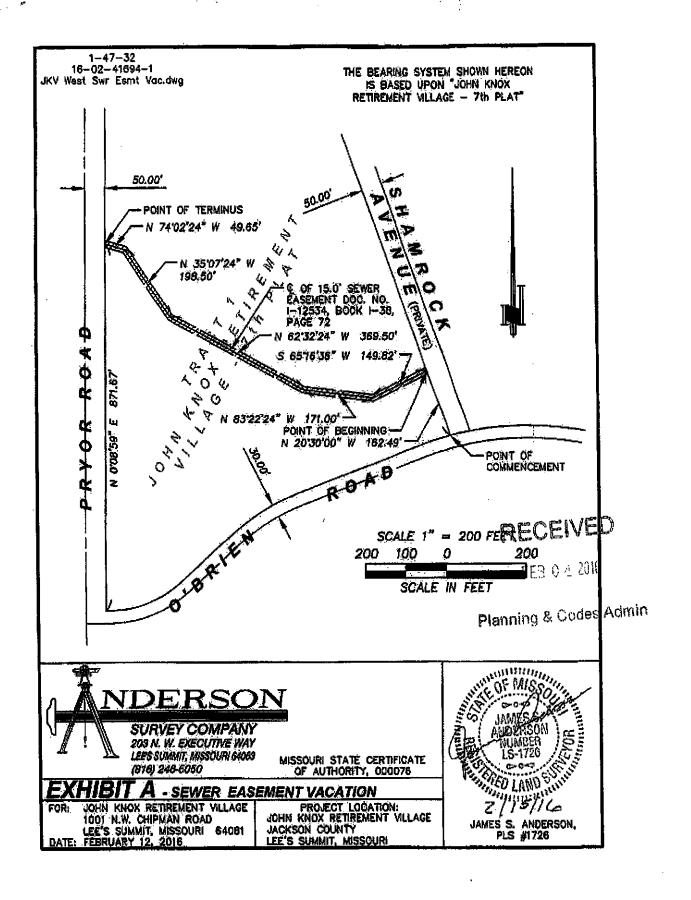
