- Architectural and other plan drawings Architectural and other plan drawings, such as site electrical and landscaping, shall be provided in Portable Document Format (PDF).
- Studies Studies, such as stormwater and traffic, shall be provided in Portable Document Format (PDF).
- It is requested that each plan sheet be a maximum of 2MB.

- 2. LIABILITY INSURANCE. The proof of liability insurance did not meet the minimum coverage requirements. Coverage shall be for not less than \$2,000,000 per occurrence for personal injury and \$2,000,000 per occurrence for property damage. Additionally, the City shall be listed as an additional insured.
