Mayor and City Councilmembers,

Below and attached please find a request from Mr. Park with Whispering Woods Land, LLC that is being forwarded on as requested for review and consideration. Whispering Woods Land, LLC understands unless the Council, at the March 9, 2017 meeting approves a motion to reconsider, the preliminary development plan and rezoning application is denied and no other opportunities exist for the Council to consider the proposed subdivision development under the current application.

In an effort to provide the various options that Council could take with this application staff has identified the following:

• If no reconsideration of the denial were made at the March 9, 2017 Council meeting, the developer will be required to wait 60 days prior to filing a new application (per Section 4.290 of the UDO), then could file a new application, pay appropriate fees and begin the development review process as a new application. (Per Council Rules Section 2-44, the March 9, 2017 meeting would be the latest any motion to reconsider may be made on the application).

• If a motion to reconsider were made and approved, the preliminary development plan and rezoning application would then be back before the City Council for consideration. If a motion to reconsider this application were to be made, the motion must come from the prevailing side of the March 2, 2017 vote to deny the application.

The Council could then take either of the following actions on the matter

- o Remand the application back to the Planning Commission (staff would suggest the application be re-advertised for a new public hearing before the Planning Commission in the event any changes were made to the application).
- o Place the application on a future City Council agenda after properly re-advertising for a new public hearing before the Council.

Given the receipt of this request from the developer, staff will work with the Law Department to prepare motions that would be appropriate for these various actions and have them available at the March 9, 2017 Council meeting should there be a desire to reconsider the denial of the application. If there is no desire to reconsider the March 2, 2017 denial of the application, no further action by the City Council is necessary.

We would be happy to provide additional information or answer questions with regard to this matter. Staff has thoughtfully responded to the developer's inquiries after the March 2, 2017 denial of the application and assisted them in understanding the options previously noted.
