- 2. Proposed name of subdivision shall not duplicate or closely approximate the name of any existing subdivision. Please update subdivision name to be "JOHN KNOX RETIREMENT VILLAGE, LOTS 3A, 3B, & 3C".
- 3. Please update plat dedication statement with new plat title.
- 4. Please update city signature block to read "Robert G. McKay, AICP, Director of Long Range Planning and Special Projects".
- 5. Please include a statement dedicating all easements. Language shall be added to every plat in which an easement is dedicated, stating that the grantor, on behalf of himself, his heirs, his assigns and successors in interest, hereby waives, to the fullest extent allowed by law, including, without limitation, Section 527.188 RSMo. (2006) any right to request restoration of rights previously transferred and vacation of the easements herein granted.
