- 4. Please update city signature block to read "Robert G. McKay, AICP, Director of Planning and Special Projects".
- 5. Please make the following changes to the lot identifiers.

Change Lot 1 to Lot 3A Change Lot 2 to Lot 3B Change Lot 3 to Lot 3C

- 6. All easements shown on the minor plat are existing. Please identify the type of easement located along Peace Pkwy and add word "Existing" to all the plat identifiers.
- 7. Please remove the streets, driveways, structures, sidewalks and all other identifiers for structure or paved surfaces prior to re-submittal.
