RIGHT OF WAY DEED (Limited Liability Company)

THIS AGREEMENT, made this ______ day of November, 2017, by and between M-III Longview, LLC, Grantor, a Limited Liability Company organized and existing under the laws of the State of Delaware, and the City of Lee's Summit, Missouri, a Municipal Corporation with a mailing address of 220 S.E. Green, Jackson County, Lee's Summit, Missouri 64063, Grantee.

WITNESSETH, that the **Grantor**, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to it paid by the **Grantee**, the receipt and sufficiency of which are hereby acknowledged, does by these presents grant, bargain, sell, convey, and confirm unto said **Grantee**, its successors and assigns, a Right of Way easement for all lawful purposes including the construction, improvement, reconstruction and maintenance of a right of way and landscaping and improvements therein for public use as a street, roadway or thoroughfare, including but not limited to, the use and maintenance of conduits, water, gas, sewer pipes, poles, wires, surface drainage facilities, ducts, cables on, over, along, across, and under the lots, tracts, or parcels of land (collectively, the "Easement Area") lying, being and situated in the County of Jackson, and the State of Missouri, and legally described on Exhibit A attached hereto and incorporated herein by this reference.

GRANTOR further states that it is lawfully seized of title to the Easement Area through which said easement is granted and that it has good and lawful right to convey said easement to the **Grantee** herein.

GRANTOR, to the fullest extent allowed by law, including, without limitation, section 527.188, RSMo. (2006), hereby waives any right to request vacation of the easement herein granted.

GRANTEE shall maintain the Easement Area and all improvements therein from time to time in accordance with all applicable laws, codes, ordinances and regulations applicable thereto, at Grantee's sole cost and expense.

THIS GRANT and easement shall, at all times be deemed to be and shall be, a continuing covenant running with the land and shall be binding upon the successors and assigns of the **Grantor**.

TO HAVE AND TO HOLD THE SAME, together with all appurtenances and immunities thereunto belonging or in any way appertaining, unto the City of Lee's Summit, Missouri, a Municipal Corporation, and to its successors and assigns forever.
