IRREVOCABLE CONSENT TO DEDICATE A SANITARY SEWER AGREEMENT

THIS AGREEMENT, made this 3/57 day of JANUARY , 2018, by and between Hunt Midwest Real Estate Development, Inc, a Missouri Corporation, 8300 NE Underground Dr, Stop 100, Kansas City, MO 64161, Grantor, and the City of Lee's Summit, Missouri, a Municipal Corporation with a mailing address of Jackson County, Missouri, 220 S.E. Green Street, Lee's Summit, Jackson County, Missouri 64063, Grantee.

WITNESSETH, that the Grantor, and for its successors in interests and assignees, does by agree to execute a 30foot wide sanitary sewer easement, in a form used customarily by the Grantee, for purposes of development of the parcel of land that generally lies north of Eagle Creek - Fifteenth Plat, Tract Q unto said Grantee, its successors and assigns, for the construction, operation, maintenance, repair, replacement and removal of sewer pipe lines, manholes, and appurtenances thereto, including the right and privilege at any time and from time to time to enter upon said easement, over, under, through, across, in and upon the following described lands in Jackson County, Missouri, to-wit:

Through Eagle Creek - Fifteenth Plat, Tract Q with the actual Easement description to be prepared at a future date but generally located within Eagle Creek Fifteenth Plat - Tract Q, on the West/Nothwest side of the creek for a total possible width of thirty (30) feet where said easement may be located. Additional temporary construction easement to be granted until line is installed and accepted by the City.

GRANTEE may delegate the responsibilities of the GRANTEE to the developer of said Parcel adjacent and lying north of said Tract Q, its successor and assigns.

Prior to execution of the easement the Grantor requires the following be completed or a Letter of Credit be established for those items that cannot be completed prior to the execution of this agreement:

-GRANTOR or its assignee must approve the sanitary sewer route

- -GRANTEE or its assignee must be allowed full access to the provided easements during the installation of the sanitary sewer main
- -GRANTEE or its assignee will pay all fees, permit costs, bond fees, design fees, construction fees and any and all other fees required to install the sanitary sewer main
- -GRANTEE or its assignee will restore the existing ground to pre-construction conditions
