- Studies – Studies, such as stormwater and traffic, shall be provided in Portable Document Format (PDF).
- It is requested that each plan sheet be a maximum of 2MB.

1. STRUCTURAL ALTERATION PERMIT. Staff acknowledges the most recent response indicating that:
- the tower owner, American Tower Corporation, will submit for a structural alteration permit through the City;
 - the tower owner will provide documentation to indicate that the necessary antenna mount modification has been completed; and
 - the tower owner will provide documentation of passage of a third-party inspection for the antenna mount modifications.

Staff cannot issue approval of the final development plan application authorizing the wireless equipment upgrades until the necessary permit is obtained, the antenna mount modification is completed and the City receives documentation showing that the antenna mount modification has passed a third-party inspection.
