

AN ORDINANCE APPROVING A PRELIMINARY DEVELOPMENT PLAN LOCATED AT 150 NE TUDOR ROAD, PROPOSED DOUGLAS CORNERS LOT 1B DEVELOPMENT IN ACCORDANCE WITH THE PROVISIONS OF CHAPTER 33, THE UNIFIED DEVELOPMENT ORDINANCE OF LEE'S SUMMIT CODE OF ORDINANCES, FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Application #PL2018-108 submitted by HG Consult, Inc, requesting approval of a preliminary development plan in District CP-2 (Planned Community Commercial District) on land located at 150 NE Tudor Rd. was referred to the Planning Commission to hold a public hearing; and,

WHEREAS, the Unified Development Ordinance provides for the approval of a preliminary development plan by the City following public hearings by the Planning Commission and City Council; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for the consideration of the preliminary development plan on September 11, 2018, and rendered a report to the City Council recommending that the preliminary development plan be approved; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on October 2, 2018, and rendered a decision to approve the preliminary development plan for said property.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That a preliminary development plan is hereby approved in District CP-2 on the following described property:

Section 31, Township 48 North, Range 31 West, in Lee's Summit, Jackson County, Missouri, being described as follows:

*LOT 1B, DOUGLAS CORNER LOTS 1A & 1B, A SUBDIVISION IN LEE'S SUMMIT,
JACKSON COUNTY, MISSOURI.*

SECTION 2. That the following conditions of approval apply:

1. A modification shall be granted to the high-impact landscaping buffer requirement along the R-1 zoned properties to the north, to allow no landscaping buffer along the north property line.
2. A modification shall be granted to the medium-impact landscaping buffer requirement along the PI zoned property to the east, to allow no landscaping buffer along the east property line.

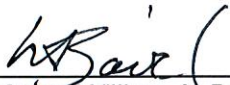
SECTION 3. That development shall be in accordance with the preliminary development plan, date stamped August 7, 2018, appended hereto and made a part hereof.

SECTION 4. Nonseverability. All provisions of this ordinance are so essentially and inseparably connected with, and so dependent upon, each other that no such provision would be enacted without all others. If a court of competent jurisdiction enters a final judgment on the merits that is not subject to appeal and that declares any provision or part of this ordinance void, unconstitutional, or unenforceable, then this ordinance, in its collective entirety, is invalid and shall have no legal effect as of the date of such judgment.

SECTION 5. That failure to comply with all of the provisions contained in this ordinance shall constitute violations of both this ordinance and the City's Unified Development Ordinance, enacted by Ordinance No. 8443 and amended from time to time.

SECTION 6. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

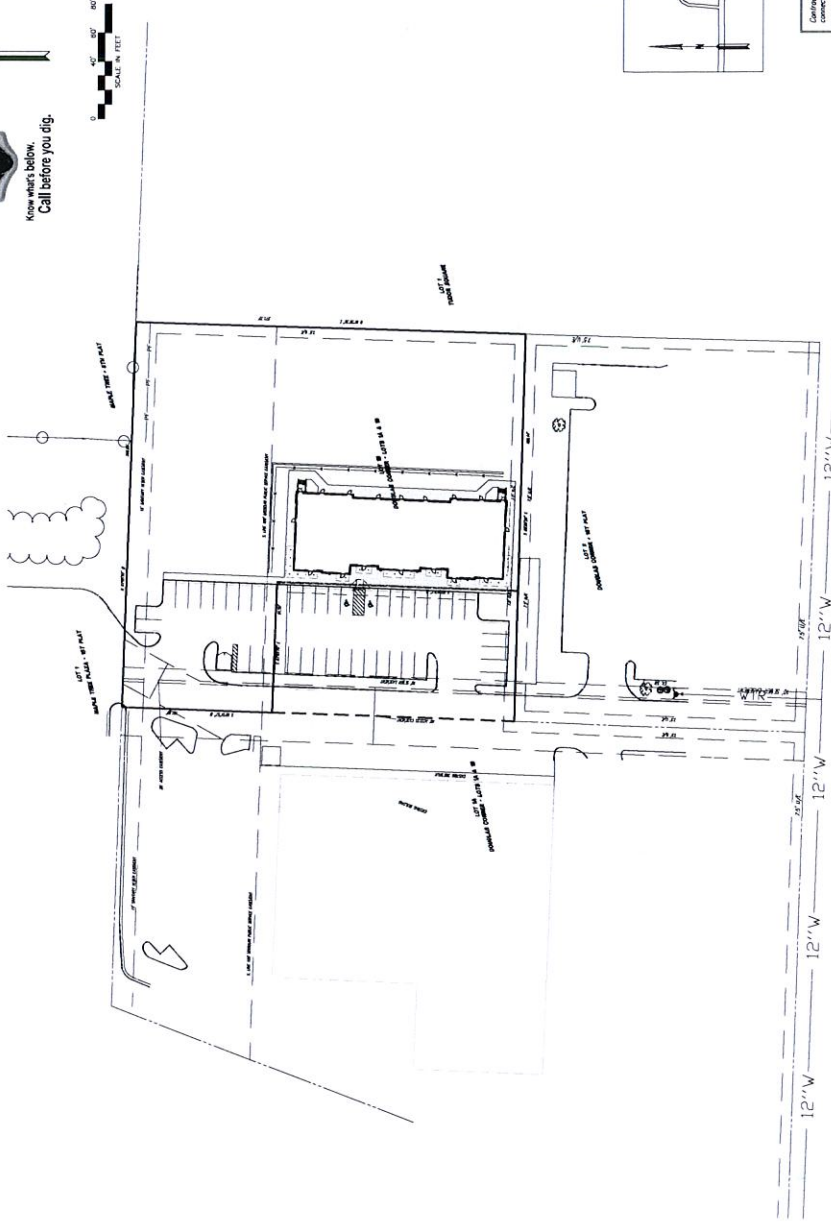

VICINITY MAP

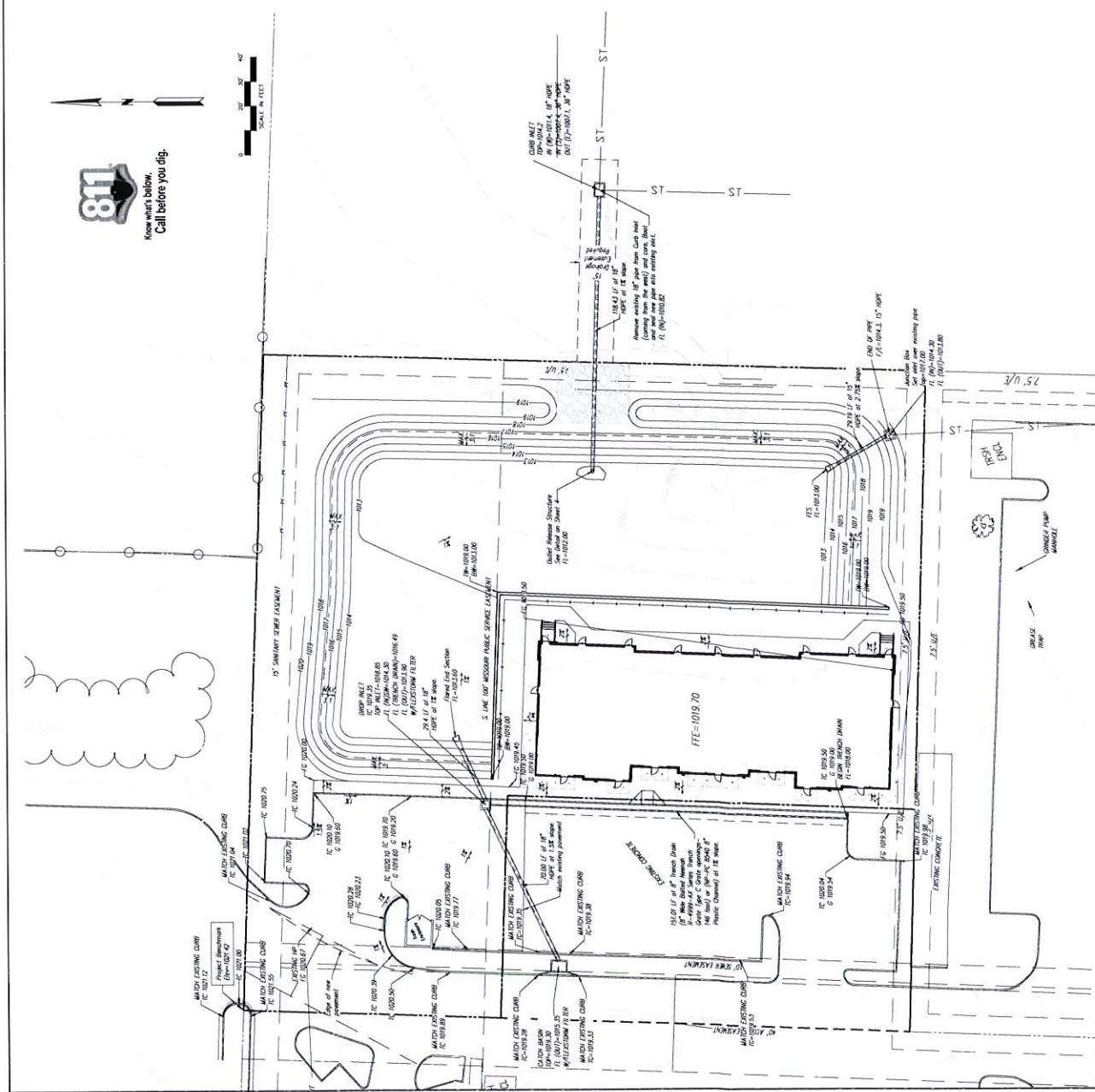

2. Subgrade to be compacted to 95% standard proctor density.
3. All units to be 12" x 12" x 8".
4. Contractor shall verify the exact location and depth of all existing utilities prior to construction.
5. Checkers are called out to top of curb, top of pavement, or top of structure, unless otherwise noted.
6. All structures shall be constructed with steel.
7. Paving and grading shall be performed to raise storm water as directed to the storm collection system.
8. Grading to be performed to passively drain away from the building.
