Dear Mr. Kenney:

Enclosed is approval on plans for a waterline extension to serve the Summit View Farms, 3rd Plat development in Lee's Summit, of Jackson County, Missouri, which I believe, is self-explanatory.

Please be advised this facility may be required to obtain other permits from the Missouri Department of Natural Resources. It is your responsibility to insure that any and all necessary permits for this facility have been obtained.

NOTE: The proposed waterline will connect to an existing 8-inch main that will provide an available flow of 3,147 gallons per minute at a pressure of 72.5 psi.

NOTE: When a connection is made to a new customer or location previously served by a private well, the Public Water System is responsible for notifying the well owner of their obligation to plug any abandoned well pursuant to the requirements of Section 256.628 RSMo., and for providing the well owner with notification forms that must be completed by the owner. These forms must then be submitted to the Department by the Public Water System within 60 days of the connection.

NOTE: You, as the applicant, should be aware that you will need to obtain final construction approval from the Department for this project, once it has been constructed and completed. In order to do this, you will need to have your engineer complete the enclosed "Statement of Work Completed" form, or online at <https://dnr.mo.gov/forms/780-2825-f.pdf>. This may require you to make additional arrangements with your engineer to provide this service to you. Once your engineer has completed this form for you, you should return it to this office. We will then make arrangements with our regional office staff to conduct a final inspection and issue a final construction approval.

If you were adversely affected by this decision, you may be entitled to an appeal before the Administrative Hearing Commission (AHC) pursuant to Section 621.250, RSMo. To appeal, your petition must be filed with the AHC within 30 days after the date this decision was mailed or the date it was delivered, whichever date was earlier. If any such petition is sent by any method other than registered or certified mail, it will be deemed filed on the date it is received by the AHC. 

INTRODUCTION

Detailed plans and specifications dated October 29, 2018, for a waterline extension to serve the City of Lee's Summit, in Jackson County, Missouri were submitted for review and approval by Larkin Lamp Rynearson, of Kansas City, Missouri.

BRIEF DESCRIPTION

In general, these plans and specifications provide for a waterline extension to serve Summit View Farms, 3rd Plat, in the City of Lee's Summit, of Jackson County, Missouri. Approximately 1,808 lineal feet of 8-inch and 385 lineal feet of 6-inch Class 235 SDR-18 PVC pipe conforming to AWWA C900 standards will be installed. The necessary valves, fittings, hydrants, and other appurtenances conforming to AWWA standards will be provided as per detailed plans and specifications. Before being placed in service, the waterlines will be pressure tested, flushed, disinfected, and sampled for bacteriological analyses.

APPROVAL TO CONSTRUCT

The engineering plans and specifications described above were examined as to sanitary features of design which may affect the operation of the sanitary works, including size, capacities of the units, and factors which may affect the efficiency and ease of operation. Approval as regards these points is hereby given.

Approval is given with the understanding that final inspection and approval of the completed work shall be made by the Department of Natural Resources before same is accepted and placed in operation. If construction is not commenced two (2) years after the date of issue or there is a halt in construction of more than two years, the approval to construct will be void unless an extension of time has been granted by the department.

In the examination of plans and specifications, the Department of Natural Resources, Public Drinking Water Program does not examine the structural features of design or efficiency of mechanical equipment. This approval does not include approval of these features.

The Department of Natural Resources, Public Drinking Water Program reserves the right to withdraw the approval of plans and specifications at any time it is found that additional treatment or alterations are necessary to assure reasonable operating efficiency and to afford adequate protection to public health.
