- Add a note to Lot 3 that references Surveyor's Note #7. Add a similar note to any newly affected lots, if any, resulting from the updated floodplain information.

4. RIGHT-OF-WAY. Label the ROW width for SW Raintree Parkway.

5. REVISIONS. The revisions listed in this correspondence need to be made prior to the submittal of the plat for signature. Please make the changes above and send me an electronic copy for review.
