Engineering plans for Eagle Creek 16th Final Plat were approved by the City of Lee's Summit, Missouri on August 6th, 2018; however, the developer, Hunt Midwest, was not ready to proceed with development at that time, due to the number of developable lots available in Eagle Creek. The developer is now ready to move forward with construction, but the plans have expired, as it has been more than one year since plans were reviewed and approved. Section 1007 of the Lee's Summit Design and Construction manual states that "Resubmission of Engineering Plans will be required for re-view and re-approval if construction has not commenced within one year from the date of plan approval."

Olsson has reviewed changes to the Design and Construction manual and found that the only changes since approval of the plans in 2018 are updates in the Standard Details: General section. The effected details have been updated in the plans provided to the City of Lee's Summit, Missouri.

Therefore, Hunt Midwest Real Estate Development, Inc. requests a modification to the requirement for re-submittal and re-review and to be allowed to use the plans, as approved and updated.
