

#### ARTICLES OF INCORPORATION OF A NONPROFIT CORPORATION

(To be submitted in duplicate with a filing fee of \$25.00)

The undersigned natural person of the age of eighteen years or more for the purpose of forming a corporation under the Nonprofit Corporation Law of Missouri adopts the following Articles of Incorporation:

- (1) The name of the Corporation is Eagle Creek Home Owners Association
- (2) The Corporation is a Mutual Benefit Corporation.
- (3) The period of duration of the Corporation is perpetual.
- (4) The name and address of the Corporation's Registered Agent and Registered Office in Missouri is:

- This Corporation is organized as a Missouri nonprofit mutual benefit corporation and the nature of the business or the purposes to be conducted or promoted are to (a) own and provide for the maintenance, repair, replacement, improvement, preservation and control of the common areas which are a part of Eagle Creek Subdivision in the City of Lee's Summit, Missouri, according to the preliminary plat thereof (the "Subdivision"), (b) enforce the recorded restrictions placed of record on the property located within the Subdivision according to the terms thereof, (c) promote the health, safety and welfare of the owners of the lots in, and users of, the Subdivision, (d) generally conduct the business of a homes or home owners association and (e) engage in all other lawful activity for which nonprofit corporations may be organized under the Missouri General Nonprofit Corporation Law.
- (7) The Corporation has members. The owner of each lot within the Subdivision shall be a member of the Corporation. If a lot is owned by more than one person, all owners of the

lot, collectively, shall be deemed the member of the Corporation for such lot. The Corporation shall be the sole judge of the qualifications of its members and of their right to participate in its meetings and proceedings. Members may be divided into classes having the rights, powers and authority as are established, from time-to-time, by the bylaws of the Corporation.

- (8) Pursuant to Missouri Revised Statutes 355.661(2)-(3), upon dissolution and after the winding up of the affairs of the Corporation, whether voluntary or involuntary, and after all debts have been satisfied, assets remaining shall be distributed to the members of the Corporation in accordance with all applicable laws.
- (9) The initial board of directors shall have three (3) members, whose names and addresses are as follows:
  - Lee A. Derrough, 8300 Underground Drive, Suite 100, Kansas City, MO 64161 Ora H. Reynolds, 8300 Underground Drive, Suite 100, Kansas City, MO 64161 Tamara S. Henderson, 8300 Underground Drive, Suite 100, Kansas City, MO 64161.
- (10) The affairs of the Corporation shall be managed by a board of directors. The number of directors shall be fixed by the bylaws of the Corporation, except for the number of the initial board of directors set forth in numbered paragraph 9 above; provided, however, in no event, shall the number of directors of the Corporation be less than three (3).
- (11)Members of the Corporation shall be either Class A Members or Class B Members. The qualifications, rights and privileges of the two classes of Members, including voting rights, shall be set forth in the Corporation's bylaws. No amendment, cancellation or revocation of such qualifications, rights or privileges shall be made without the affirmative vote of a majority of all votes entitled to be cast by all Members. In addition, Class A Members or Class B Members, as the case may be, are entitled to vote as a class on a proposed amendment to the Corporation's bylaws if such amendment would: (a) affect the rights, privileges, preferences, restrictions or conditions of such class as to voting, dissolution, redemption, or transfer of memberships in a manner different than such amendment would affect another class; (b) change the rights, privileges, preferences. restrictions or conditions of such class as to voting, dissolution, redemption or transfer by changing the rights, privileges, preferences, restrictions or conditions of another class; (c) increase or decrease the number of memberships authorized for such class; (d) increase the number or memberships authorized for another class; (e) effect an exchange, reclassification or termination of all or part of the membership of such class; or (f) authorize a new class of membership. If a class vote is required to approve an amendment to the Corporation's bylaws, such amendment must be approved by the members of such class by the lesser of either two-thirds of the votes cast by the class or a majority of the voting power of the class.
- (12) At all times the Corporation has Class B Members, these Articles, including this Article 12, may be amended, canceled or revoked only by the affirmative vote of a majority of all Members, with both Class A and Class B Members voting as a single class. At all other times, the provisions of these Articles may be amended, canceled or revoked by the affirmative vote of a majority of all Members; provided, however, the terms of Article 11 hereof, this Article 12 and the provisions of the bylaws of the Corporation concerning

amendment of the Corporation's bylaws may be amended, canceled or revoked only with the approval of at least two-thirds of the Members and provided, further that any provision of the Corporation's bylaws requiring the approval of a percentage of the Members that is greater than a majority shall only be amended or modified by such higher percentage. Nothing contained herein shall effect to the rights of the Members granted by Missouri Revised Statutes 355.556.

(13) The effective date of this document is the date it is filed by the Secretary of State of Missouri.
