1. BUILDING ELEVATIONS. The elevations submitted are not clear and the notes are difficult to read. Provide revised elevations that identify all exterior building materials, colors and light fixtures.

2. LIGHT FIXTURES. Cut sheets for all exterior wall pack light fixtures shall be provided for review. The light fixtures shall have full 90-degree cutoffs to direct the light downward and so the light source is not visible from off the property.

3. APPLICATION. The application provided did not include the signature of the property owner. An application signed by the property owner is required to be submitted.

4. ACCESSIBLE PARKING SPACE. Revise the note regarding the mounting height of the sign to a minimum of 5' above grade, measured to the bottom of the sign.

5. VICINITY MAP. Add a vicinity map to provide more context to the hangar site within the airport and surrounding area at large.

6. SODDING. All disturbed areas surrounding the hangar shall be sodded.

7. PARKING SPACES. Dimension the parking spaces. The spaces shall be a minimum 9' x 19'.
