### **Tentative Schedule**

Submit revised plans by <u>noon on</u> (4 full size paper copies, 1 reduced 8 ½" x 11" copy, and 4 copies of the comment response letter).

City Council date will be set after all subdivision related public improvements have been completed and a Certificate of Final Acceptance has been issued. In lieu of completion of public improvements, an escrow secured with cash or an irrevocable letter of credit shall be deposited with the City to secure the completion of all public improvements prior to scheduling a City Council date.

If the revised submittal deadline is not met or plans are deficient, the item will be moved to a later meeting and a new deadline will be set. Future deadlines and meeting dates can be found on the "Planning Commission Meeting Dates" handout. Dates are subject to change; we will keep you informed throughout the process.

### **Electronic Plans for Re-submittal**

All Planning application and development engineering plan resubmittals shall be include an electronic copy of the douments as well as the required number of paper copies.

#### **Excise Tax**

On April 1, 1998, an excise tax on new development for road construction went into effect. This tax is levied based on the type of development and trips generated. 1. Please provide ITB for street centerline on western edge of Killarney.

2. The bearing on Ambersham just NE of Killarney has an incorrect distance. Instead of 180.45, I believe it should be 150.45

3. Plat does not close. I believe the ITB on Killarney (near coordinate 23) is incorrect. It needs to bear more northeasterly.For example, when I change the ITB to S81-05-10E, the plat closes (x=.003, y=.084).

4. Please change the direction of the 2nd curve in the legal description to RIGHT.

5. Please confirm that the bearing between coordinates 9 and 10, 11 and 12, and 13 and 14 should be S04-27-05W instead of S04-27-07W, a difference of 2 seconds. The same with the bearing between 12 and 13, also being a difference of 2 seconds from previous version. This change will not affect closure, it's just such a small change I want to verify it.
