- 2. APPLICATION. The application provided did not include the signature of the property owner. An application signed by the property owner is required to be submitted.
- 1. LIGHT FIXTURES. Cut sheets for all exterior wall pack light fixtures shall be provided for review. The light fixtures shall have full 90-degree cutoffs to direct the light downward and so the light source is not visible from off the property.

1. An itemized and sealed Engineer's Opinion Of Probable Construction Costs has not been provided. The Final Development Plan's engineering review fee and the inspection fee are based on this estimate, and calculated at 3% of the total. Items to include in the estimate include: 1) grading to establish proper drainage, 2) grading for parking, 3) removal and replacement of poor quality subgrade (estimated quantity), 4) water and sanitary utility items, 5) pavement, 6) erosion and sediment control, 7) final restoration, including sodding, seeding, fertilizer, mulch, and topsoil.

All issues pertaining to life safety and property protection from the hazards of fire, explosion or dangerous conditions in new and existing buildings, structures and premises, and to the safety to fire fighters and emergency responders during emergency operations, shall be in accordance with the 2018 International Fire Code.
