1. PLAT TITLE. Revise the plat title to read, Oakview, Lots 5A and 5B. Also update all references to the plat title contained throughout the document to reflect the title change.

2. ADDRESSES. Label each lot with the following respective addresses: Lot 5A - 1460; and Lot 5B - 1450.

3. SIDEWALKS. Show and label the existing sidewalk along NE Douglas St, including its width.

4. DATES. Update the years referenced in the property owner signature paragraph and notary certification paragraph from 2019 to 2020.

5. ACCESS EASEMENT. Add an access easement dedication paragraph to the plat document. See the previous Oakview plat document for language.

6. DEDICATION PARAGRAPHS. Add the City's standard plat dedication paragraphs. See the sample under UDO Section 7.140.B.21. However, do not include the Streets or Common Area dedication paragraphs, due to the inapplicability to this particular plat.

7. CITY SIGNATURE BLOCK.

- Remove the Mayor's and Planning Commission Secretary's signature lines.

- Revise the approval language above the City signature lines to read, "This is to certify that the minor plat of 'Oakview, Lots 5A and 5B' was submitted to and duly approved by the City of Lee's Summit, pursuant to Chapter 33, the Unified Development Ordinance, of the Lee's Summit Code of Ordinances."

8. STATE PLANE COORDINATES. Label all the lot corners with their respective state plan coordinates.
