

Purpose of Final Plats

The City of Lee's Summit requires that all property be platted before a building permit is issued. Platting involves the subdivision of land into lots or tracts. A plat is recorded as a permanent legal document that includes both an accurate legal description, as well as a graphical depiction of any real property that is to be divided. The intent of platting is to provide a readily accessible and easily understandable public record of property. Units of property that have been created by platting can be easily transferred between interested parties.

Subdivision plats dictate:

- sizes and shapes of lots;
- relationship between existing and future streets;
- location of proposed public improvements; and
- location of lands dedicated for public purposes

As a result, the purpose of the platting step is to ensure that:

- a sensibly arranged pattern of lots results for the intended uses
- streets and public improvements are planned to serve the needs of each lot as well as surrounding properties
- · consistency is provided between subdivisions

The final plat drawing generally represents only one phase of development within the approved preliminary plat. The final plat must conform with the approved preliminary plat, but the final plat is more detailed than the preliminary, including exact dimensions of each lot, easement locations, and dedication language for all public streets and easements. The Planning Commission will recommend and City Council will take final action on a final plat with the passage of an ordinance. Property owners and city officials will sign the approved version of the final plat drawing that will ultimately be recorded at the County Recorder of Deeds office.



Step 1 - Engineering Plans

The City of Lee's Summit requires detailed engineering plans to be submitted at the same time as the final plat, for public improvements needed to serve the development, including sanitary sewers, storm sewers, water lines and streets. These plans will be reviewed to determine if the water, sanitary sewer system, storm sewer system, streets and erosion control in the proposed development comply with the General Design standards in the city's Design and Construction Manual (D&C Manual). *A final plat application will not be reviewed until the Engineering Plans have been submitted.*

Step 2 – Filing the Application

An application for final plat must be completed and submitted to the Development Services Department, with the proper filing fee, payable to the City of Lee's Summit. See the Schedule of Fees and Charges for the applicable application fee.

An application may be withdrawn at any time upon written request; however, no refund will be made after the application has been processed.

A complete application consists of all items identified in the Submittal Requirements checklist.

Final plat applications will be placed on the Planning Commission agenda based upon the completeness of the application submittal. All additional information, which is to support the application, must be submitted by the deadline. Information missing or not submitted by the deadline date, will result in a delayed application.

Step 3 – Development Review Committee (DRC)

Every application goes through a detailed staff review. A Project Manager is assigned to coordinate the review of each application. After the application is submitted, plans are routed to several departments for review and then discussed by the Development Review Committee. This is a staff-only committee consisting of 10 to 15 representatives of various city departments and divisions that reviews each item on the agenda and identifies relevant issues. Out of this meeting, the development departments will prepare written comments on the proposed application. The staff comments will be sent to all parties listed on the application form (via fax or email) on the Friday before the Tuesday Applicant's Meeting.

Step 4 – Applicant's Meeting

The purpose of the applicant's meeting is:

- to allow City staff to present a preliminary, technical review of submitted plans,
- to request from the applicant any necessary plan revisions
- to give the applicant an opportunity to ask questions, and
- to work out a schedule for submitting revised plans.



The applicant will meet with staff (generally, Development Services, Public Works, Fire, and Parks) at the Strother Conference Room in City Hall. If deficiencies are minor, the item will be scheduled for a Planning Commission meeting, subject to revised plans being submitted by the Revised Plans Due date.

This meeting is *not* the appropriate forum to discuss policy issues or negotiate any agreements. If a case involves policy issues or items that may be resolved through a development agreement, the Development Services Department will schedule a separate meeting with appropriate City staff.

However, alternative solutions to technical problems that are within the authority of the staff to consider may be discussed. If an applicant has questions, it would be helpful to call ahead of time so the staff can be prepared with answers at the meeting.

If extensive changes are being made or more information is needed to adequately review the application (e.g. additional traffic or engineering studies), then the application may be "continued" (i.e., rescheduled to a later Planning Commission meeting date to allow time for the necessary work to be completed).

Step 5 - Planning Commission Meeting

Every final plat application is reviewed by the Planning Commission. The Commission consists of nine (9) appointed citizens who meet on the second and fourth Thursday of each month in the City Council Chambers of City Hall at 220 SE Green St.

In most instances, a final plat application will be placed on the Consent Agenda, in which case no presentation is necessary; however, the applicant is advised to be present to answer any questions the Planning Commission may have. The Commission votes on the Consent Agenda without any discussion, but if they have questions, they may move the item to the regular agenda.

For each item on the regular agenda, the applicant (or their representative) is expected to make a presentation. Presentations should be a brief description of the proposed project and include responses to any concerns raised in the City staff's report.

While final plats do not require any public hearings and are not advertised for public input, citizens who wish to address the Commission are generally allowed to do so.

Finally, the Planning Commission discusses the action that should be taken and the reasons for that action. The Planning Commission's action is a recommendation to the City Council to either approve, approve with conditions, or deny the application. The Planning Commission may also vote to continue an application to a later meeting to allow further study or the submission of more information or revised information from the applicant or staff. A majority vote of the Commission members present is needed to pass any motion.



Step 6 - City Council Meeting

Once the Planning Commission has made a recommendation, an ordinance accepting the final plat (typically two weeks later) will be scheduled before the City Council. The Lee's Summit City Council holds regular meetings on the first and third Tuesday of each month at the Council Chambers of City Hall at 220 SE Green Street at 6:00 p.m. Ordinances are generally read and voted on by the Council with little or no discussion. However, the applicant is advised to be present in case there are any questions.

A final plat ordinance will not be placed on the City Council agenda until either:

- a) All subdivision-related public improvements have been completed, or
- b) A irrevocable letter of credit, escrow secured with cash, or other form of security acceptable to the City has been submitted to and accepted by the City.

Step 7 – Getting a Plat Recorded

The final version of the plat submitted for signatures must be free from errors and include any revisions required as a part of the Ordinance granting approval. Any conditions must be completed before the final version of the plat is submitted. The surveyor and property owner signatures must be on the plat before city officials will sign it. Once the final version is submitted (see submittal copies chart below for correct number of copies needed for signature process), city officials will sign the plats.

A final plat does not become a legal document until it is recorded by the Jackson or Cass County Recorder of Deeds. The city will not allow a building permit to be issued until after the plat has been recorded and the necessary copies (1 mylar and 2 paper copies) returned.
