4. Addresses. Label the lots with their respective addresses: Lot 4E-1 – 420 NW Chipman Rd; and Lot 4E-2 – 400 NW Chipman Rd.

5. Signature Block. Delete the words, "...City Council of the..." in the approval language above the City signature block.

6. County Signature Block. Please include a signature line for the Jackson County Assessor's office. It should read: JACKSON COUNTY ASSESSOR OFFICE.
