- 3. Revise the plat title to "Minor Plat". Revised as requested.
- 4. A minor plat doesn't require the Mayor and City Council certification or the Planning Commission Secretary title block.

- 5. Revise the JACO department name to read: Jackson County Assessor Office. Revised as requested.
- 6. The configuration and one of the dimensions of Lot 13 is different than what is shown on Paragon
  Star 2nd Plat for the subject area. The common line between Lot 13 and the boundaries of the Second Plat have been slightly modified since the previous submittal of the Second Plat. But the common line will match in the final submittal of each plat.
