Electronic Plans for Resubmittal

Beginning Monday, May 23, 2016, all Planning application and development engineering plan resubmittals shall include an electronic copy of the documents as well as the required number of paper copies. Electronic copies shall be provided in the following formats

- Engineered Civil Plans All engineered civil plans shall be provided in multi-page Portable Document Format (PDF).
- Architectural and other plan drawings Architectural and other plan drawings, such as site electrical and landscaping, shall be provided in Portable Document Format (PDF).

Presentations before the Planning Commission and City Council shall be (1) in electronic format or (2) reduced drawings for use on the document camera to display on the screen. Electronic presentations shall be on a laptop, CD-ROM, DVD, or flash drive. allowed. The presentation(s) shall be submitted to Development Services Department staff no later than the day of the Planning Commission meeting by 4:00 pm.

1. SIGN 1.

- Sheet 3 of the plan set labels the lowercase letters as being 10" in height, but does not provide the height for the uppercase letters.
- The square footage of the actual sign portion is determined by the smallest single rectangle that can be drawn around the stacked lines of copy. Please label the overall width and height of the two lines of copy. It appears that it may be in the vicinity of 3' in height x = 10'' in width.
- 2. SIGN 2. On Sheet 6 of the plan set, label the same height and width information for the copy referenced in the previous comment, plus the tiger head component. The overall sign width will include the tiger head graphic, but not the tiger stripes to the left of the copy.
