## "Scott -

I discussed the minor plat and stream buffer issue with Sue and here is the clarification. If they are going to identify an area on the minor plat as a stream buffer then we will require the current stream buffer dedication language as provided in our last set of review comments. However since the City Engineer has determined that a "stream buffer", as defined by the City, is not required, then the referenced stream buffer area should not be labeled as a stream buffer and dedication language should not be included on the MP.

Hope this clears up the confusion. Please pass along to the developer / engineer.
