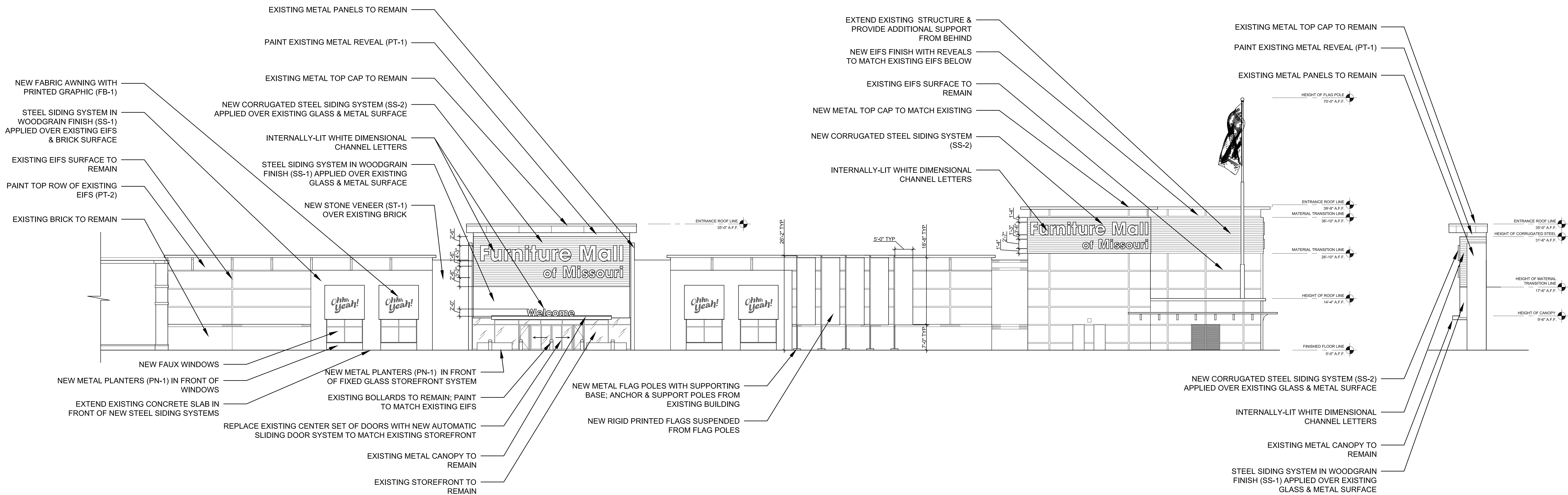


1 | EXISTING NORTH ELEVATION

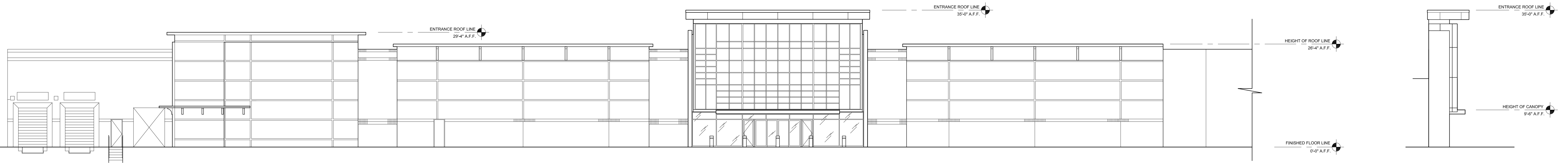

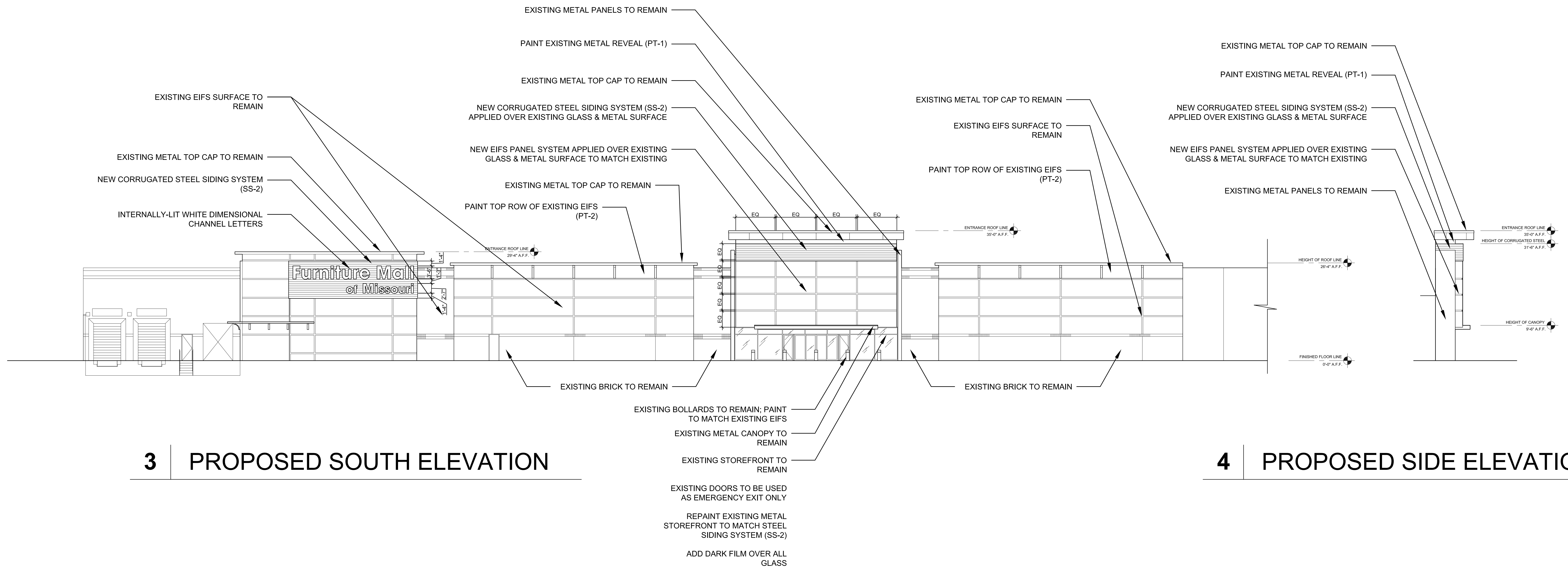

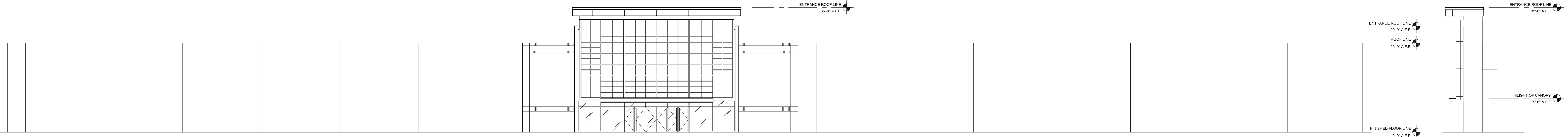

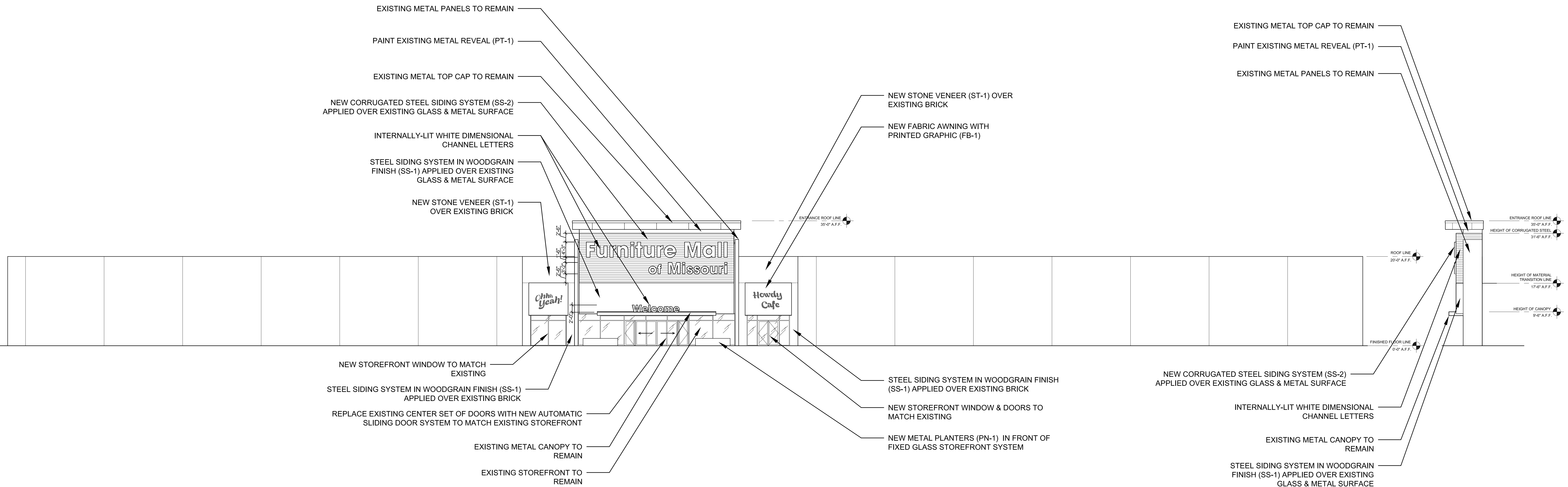

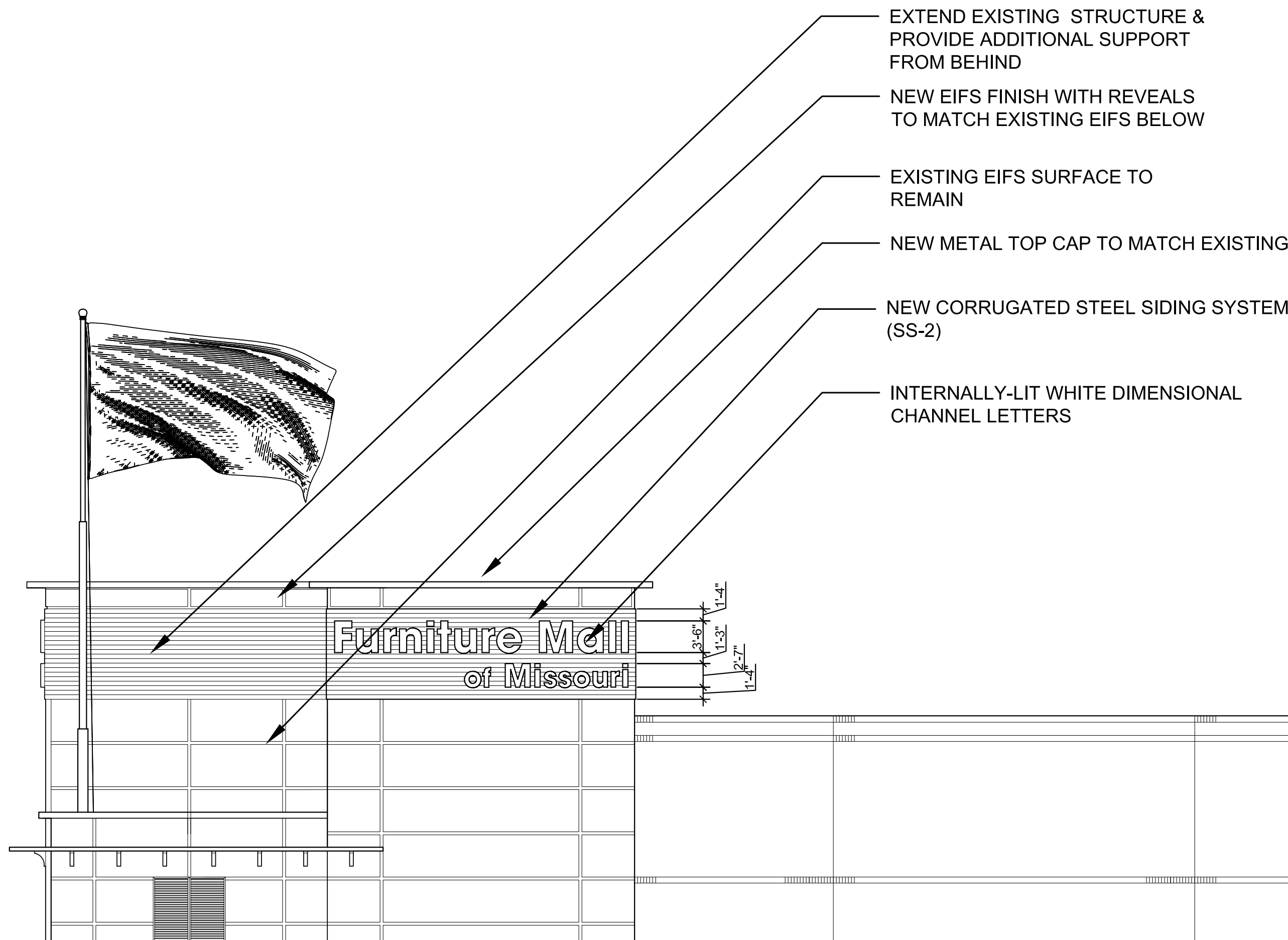

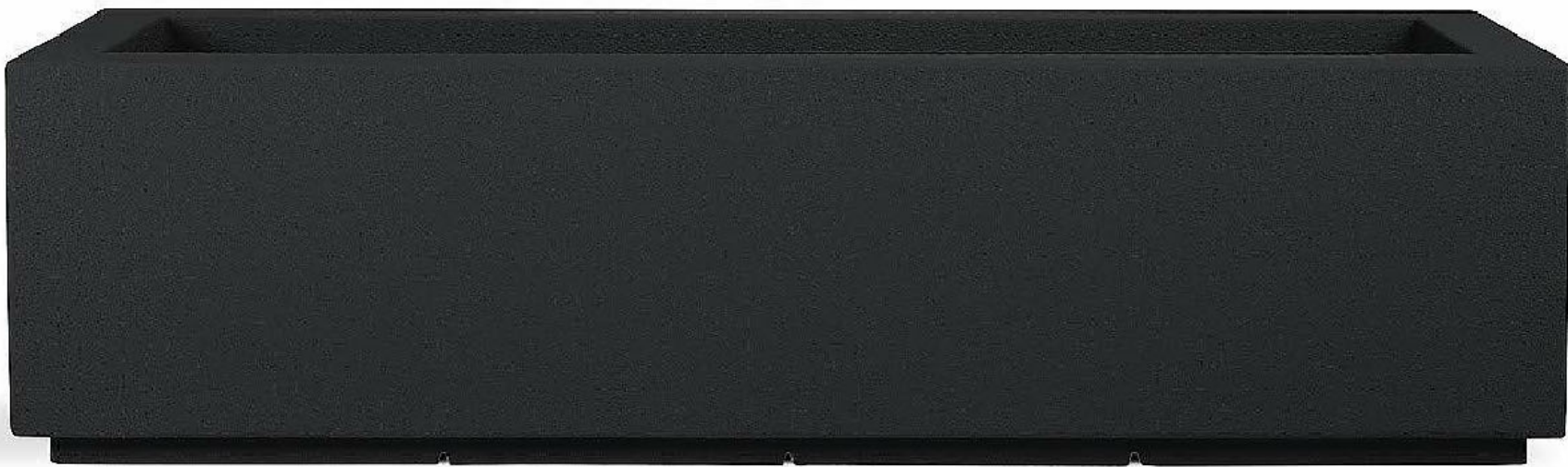
