- 2. Easements. You do not seem to be showing any sanitary sewer easements or pole guy easements. Please state whether these utilities will be in the area? If so, please label them on the plat.

  If you do not have any sanitary sewer easements please remove it from the legend.
- 3. Lot 1. Lot 1 label is already taken. Please change this to another number.
- 4. Address. Please address the lot 624. Just like the Preliminary Plat.

- 1. One (1) additional ADA-accessible route and ramp is warranted across Maguire Blvd. at Cargo Dr. Please show in concept form the location of this additional ADA-accessible ramp.
- 2. Please add the standard drainage note "Individual lot owners shall not change or obstruct the overall drainage flow lines or paths on the lots, unless specific application is made and approved by the City Engineer."
- 3. "D/E" is shown on the plat with no definition in the "Easement" section of the plat. Recommend using a U/E instead of a combined U/E and D/E at the location shown on the eastern lot line. As it is shown, D/E is not defined, and even if it were defined, it is already a dedicated use by the definition given under the "Easement" section. Please remove the contradiction.
