The cost estimate was missing the following items: 1) backflow vault, 2) water lines, 3) valves, 4) tees, bends, fittings, 5) ADA-accessible ramps, 6) sanitary wye and connections, 7) 6 inch aggregate base for pavement, 8) final restoration including sodding, seeding, fertilizer, and mulch/topsooil.
