



Commencing at the Southeast corner of Lot 11 of said Streets of West Pryor; thence N 71° 41' 12" W, A distance of 61.48 feet; thence N 87° 32' 44" W, a distance of 194.08 feet; thence N 2° 27' 16" E, a distance of 26.47 feet to the Point of Beginning; thence N 80° 33' 20" W, a distance of 20.11 feet; thence N 15° 22' 47" E, a distance of 216.84 feet; thence S 74° 37' 13" E, a distance of 20.00 feet; thence S 15° 22' 47" W, a distance of 214.76 feet to the Point of Beginning.
