1. Title and dedication are incorrect.

2. Since this plat is not replatting the individual lots on tract B of DC 2nd, please update the description to:

"All of lot 1B of the plat Douglas Corner, Lots 1A and 1B; and all of tract A of the plat Douglas Corner 2nd Plat, Lots 3-14 and Tract A and B....."

Also, remove the "TRACT A" from "PROPERTY DESCRIPTION: TRACT A" since there are 2 lots being platted.

3. Since there will be a "hole" in the western lot (it's not labeled, so I don't know what lot it is), the hole will need direction and dimensions on those sides of the hole, which are referenced on DC 2nd Plat.
