Please clarify if the whole plat is lot 1C (please remove the lot line) or if there are 2 lots (please label lots), or if the plat should only include 1C (1B and part of tract A) and then the plat drawn all the way to Tudor and Douglas is incorrect and those lines should be lightened so as not to create the illusion that it is part of the plat.
