Engineering Review - Corrections

1. The sidewalk plan and ADA-accessible routes across the new entrance need additional revision. A separate markup of Sheet C.100 is being provided separately. Please refer to this sheet and update all sheets associated with these changes. The separate sheet should be used as a guide, and other alternatives may be possible. Please ensure all aspects of the Design and Construction Manual are adhered to during design, and call if there are issues with the design. **REVISED.**

Traffic Review - Corrections

- Move STOP sign to the right of the exiting road.
 Add DO NOT ENTER with ONE WAYS on top to the left side of that exiting road. REVISED.
- 2. Add a KEEP RIGHT at the beginning of the island to direct exiting traffic. **ADDED.**
- 3. Street name signs are to be upper and lower case letters. Move the street name to the entering roadway. **REVISED.**
- 4. A waiver will be required for the intersection angle for exiting traffic. Please ensure that sight distance is adequate for exiting vehicles.
