Presentations before the Planning Commission and City Council shall be (1) in electronic format or (2) reduced drawings for use on the document camera to display on the screen. Electronic presentations shall be on a laptop, CD-ROM, DVD, or flash drive. The City's presentation system can support Word, Excel, Power Point, Adobe, Windows Media Player and Internet Explorer applications. Presentation boards will no longer be allowed. The presentation(s) shall be submitted to Development Services Department staff no later than the day of the Planning Commission meeting by 4:00 pm.

1. PROHIBITED MURAL TYPES. City ordinance prohibits the use of murals where the intended audience is commercial or actual or potential consumers, and where the content is commercial in character (Code of Ordinances, Chapter 21, Sec. 21-100.C.6). Inclusion of the business name and coffee cup in the graphic make the image commercial in nature and thus is not considered a mural under City ordinances, but rather a wall sign.

As a wall sign, the graphic is subject to the sign standards for the CP-2 zoning district outlined under UDO Section 9.260, Table 9-1. Please note that while murals may be painted onto a building, painted wall signs are prohibited under UDO Section 9.060.L. The prohibition against painted wall signs also applies to the proposed "Drive Thru" and "Oak Roasted Coffee" signs.

2. NUMBER OF SIGNS. Please note that the City's sign ordinance allows a maximum of 2 total wall signs by right for each tenant located in a multi-tenant building.
