- 3. Provide proof of general liability insurance for claims from injury or death and property damage in an amount approved by the City, but not less than \$2,000,000 per occurrence for personal injury and \$2,000,000 per occurrence for property damage with the City listed as an additional insured.
- 4. The property owner affidavit (part of the Final Developent Plan application) is missing. This form is required as is the property owner signature.
