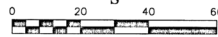
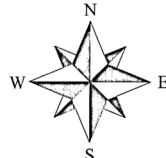

Lee's Summit, Jackson County, Missouri



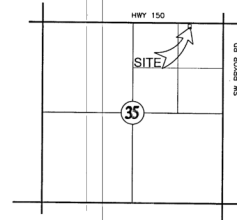

All of Lot 5, Osage First Plat, as recorded in the Office of the Recorder, Jackson County, Missouri, as Document No. 2021E0055350. Containing 0.39 acres more or less.

"OSAGE, LOTS 5-A, 5-B, 5-C & 5-D"

EASEMENTS:

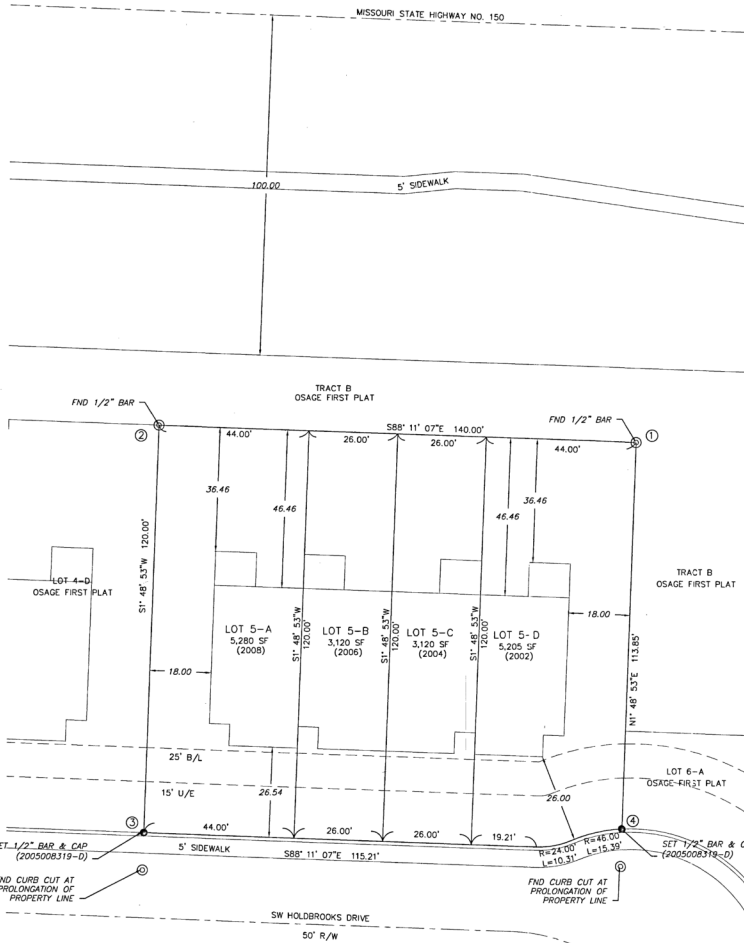
