- 1. ARCHITECTURE. Color building elevations are required to be submitted as part of the final development plan application for review. The building elevations (Sheets A-200 and A-201) are black and white, and also do not label any of the proposed material colors.
- 2. TRASH ENCLOSURE. Please confirm that the proposed trash enclosure gates shown on the detail (Sheet AS-101) are solid metal panels. It isn't very clear if the "MTL GATE" note on Detail A5 refers to the panels or the gate frame.
- 3. SIGN PERMIT. For your information, construction of the monument sign depicted on Sheet AS-101 is reviewed and approved under separate cover as part of a sign permit application and not done as part of the subject final development plan application. Having said, it does appear to comply with all applicable sign regulations as drawn. Additional information will be required regarding the proposed illumination of the sign at the time of sign permit review.

- 1. The Engineer's Estimate of Probable Construction Costs has been accepted for this project, and the Engineering Plan Review and Inspection Fee (which is calculated as 3% of the total infrastructure cost plus a water test inspection fee(s)), and the water tap and meter setup and sanitary sewer fee have been included. These must be paid prior to the issuance of an infrastructure permit and/or the final processing of a building permit. \$196,478.37
- 2. Prior to the commencement of any construction activities, the Contractor shall contact Field Engineering Inspections at (816) 969-1200 to coordinate a project coordination meeting with the assigned Field Engineering Inspector.
- 3. Please be aware that any future repair work to public infrastructure (e.g., water main repair, sanitary sewer repair, storm sewer repair, etc.) within public easements will not necessarily include the repair of pavement, curbing, landscaping, or other private improvements which are located within the easement.
