2. Add a note carrying over language regarding a blanket cross-access easement that was included on the original Douglas Square Center, Lots 1-6 subdivision plat.

4. Provide coordinates, based on the Missouri Coordinate System 1983, on the corners of the plat boundary, the control station, station coordinates, and grid factor used in accordance with the regulations of the Missouri Department of Natural Resources.

1. Plat lists coordinate system and measurement (feet) but I don't see a grid factor. The plat coordinates aren't matching after I georeference it to either a 2024 aerial (6ft off easting, 2ft northing) or a 2022 aerial (5ft off easting, 1.5ft northing), so I will have to try to apply a grid factor. If it still does not align, please double check your coordinates, as they appear incorrect.
