- 1. Please submit an Engineer's Estimate of Probable Construction Costs.
- 2. Add to the plans the City standard detail for curbs (GEN-4).
- 3. Show in the pavement section and add the following notes to the plans regarding paving per Section 2200 of the City Design and Construction Manual.
- All asphalt materials shall conform to the KCMMB ASPHALT MATERIAL SPECIFICATION, current edition.
- All concrete materials for paving curb and gutter, sidewalks, paths, commercial driveways and other pavements shall conform to the KCMMB specifications.
- 4. Please provide a graphic and notes showing the aggregate base to be extended a minimum of 12 inches beyond the back of curb. The City standard detail does not show this, so provide either a standalone curb detail or add the curb detail to the typical pavement section.
