Councilmembers Rader, Lopez, and DeMoro,

Many neighbors attended the 9/23/2024 Neighborhood Meeting hosted by Mr. Matthew Schlicht, Engineering Solutions, who represented Kevin Higdon, Choyce, LLC. The purpose of the meeting was to share the proposed rezoning plan for Chapel Ridge Townhomes. The attendance sheet and associated meeting notes were posted to the Development Portal and are included as attachments to this email. **The attendees strongly opposed the proposed construction of townhomes on NE Chapel Ridge Place adjacent to existing and future single family homes.**

Following this meeting, a “compromise” plan was emailed to Mr. Schlicht for consideration. **He responded with a revised Project Development Plan (PDP) which was then submitted to the City later that week.** The plan includes the construction of single family, maintenance-free “villas” on the west side of NE Chapel Ridge Place, two duplexes on NE Sundown Dr. adjacent to an existing single family “estate” home on NE Sundown Dr. The plan also includes enlarged “Green Spaces” and the existing ~30 ft Landscape Easement north of new townhomes on NE Sundown Dr.

As indicated in the attached Chapel Ridge Opinion Log, **nearly every homeowner(s) contacted personally supports this revised PDP.** Several, however, expressed deep concern that Mr. Higdon and Choyce, LLC will live up to the commitments made, mostly about maintaining the Green Spaces and unconstructed lots. I expect many neighbors to attend the 10/24/2024 Planning Commission Meeting and the 12/3/2024 City Council Meeting when this application is presented.

Thank you all for your attention to this application; we look forward to standing up and stating our opinions as you consider your vote.
